VENDOR/PARTICIPANT AGREEMENT

I, the undersigned, _____ (PRINT NAME), request that I be allowed to participate as a vendor at the St. George the Great Martyr Orthodox Church International Festival, pending approval, and selling the following type of items:

I understand that if my request to participate is approved, that the festival organizers will assign me space either in the church parking lot or in the church hall as they deem fit. Further, I understand that preference will be given to those exhibitors who require electricity and to prior exhibitors. I do _____ do not _____ require electricity.

I understand that if I am outside vendor, I will be required to provide my own canopy cover and that I may be required to provide my own chairs and table if directed to do so by the festival organizers. _____ (INITIALS)

I understand that there is a NON-REFUNDABLE Booth Reservation Deposit of \$50, which must be received no later than December 1, 2015, along with this application, in order to be a vendor/participant. _____ (INITIALS)

At the end of your participation in the *entire* International Festival Day, that amount (\$50.00) will be applied to your donation of 15% of your total sales, to be given to St. George the Great Martyr Orthodox Church. If 15% of your sales is LESS than \$50.00, no further donation is required. If 15% of your sales is ABOVE \$50.00, then only the amount above the \$50.00 Deposit is due at the end of the festival day. _____ (INITIALS)

Vendor Application Fee: \$50.00 Non-Refundable Application/Reservation Fee. Please send a check along with your completed application form, or pay through PayPal on this site. If you are not accepted as a vendor, that fee will be refunded. If you are accepted as a vendor, even if you do not sell at the festival, the fee WILL NOT be returned.

Festival Day Fee: + If you sell LESS than \$330 on Festival day, you owe nothing more beyond the application fee.
+ If you sell MORE than \$330, you owe 15% of any additional sales. This donation is made on the honor system. This event helps support our church and outreach ministries, such as St. George Food Pantry.
